By Order dated this 24th day of May, 2017, the Court certified the Class in this consolidated action (the "Action"). The Class consists of all record and beneficial holders of Rentrak Corporation whose Rentrak shares were converted to comScore stock when the Transaction closed, including any and all of their predecessors, representatives, trustees, executives, heirs, assigns or transferees, immediate and remote, and any person acting for or on behalf of, or claiming under any of them and each of them. Excluded from the Class are (a) Defendants, their affiliates, successors-in-interest, predecessors, representatives, trustees, executors, heirs, assigns or transferees, immediate and remote, and any person acting for or on behalf of, or claiming under any of them and each of them; and (b) the Opt-Out Members listed on Exhibit 1 attached hereto, who would otherwise be Class members but excluded themselves from the Class by submitting a valid and timely request for exclusion in accordance with the requirements set forth in the Notice of Proposed Class Action Settlement.

Pursuant to the Court's Order Granting Final Approval of Class Action Settlement signed this 12th day of September, 2017, and entered in the Action,

IT IS HEREBY ORDERED AND ADJUDGED that

(1) All claims asserted in the Action by Plaintiffs are dismissed with prejudice;

(2) All claims asserted in the Action on behalf of the Class are dismissed with prejudice;

(3) The Court retains continuing jurisdiction for the limited purpose of implementing and enforcing the Stipulation and the Order Granting Final Approval of Class Action Settlement signed September 12, 2017.

(4) Plaintiffs and each of the Class members shall be deemed to have, and by operation of this General Judgment shall have, fully, finally and forever released, relinquished and discharged all Released Claims against the Released Parties.
