4	Dec."); Declaration of Timothy S. DeJong In Support of Motion for Attorney Fees, Expenses,
5	Costs, And Disbursements For Plaintiffs' Counsel ("Stoll Berne Fee Dec."); Declaration of Carl
6	Stine In Support of Motion for Attorney Fees, Expenses, Costs, And Disbursements For
7	Plaintiffs' Counsel ("Wolf Popper Fee Dec."); Declaration of Robert Banks In Support of
8	Motion for Attorney Fees, Expenses, Costs, And Disbursements For Plaintiffs' Counsel

14	4. Litigation expenses, including costs and disbursements, are set forth in detail in
15	Exhibit 1. The total sum of these expenses, costs and disbursements is \$196,728.42.
16	5. In summary, Plaintiffs' Counsel are entitled to an award of reasonable and
17	necessary attorney fees in the sum of \$6,270,000, plus litigation expenses, costs, and expenses in
18	the sum of \$196,728.42 for a total of \$6,466,728.42, to be allocated by Class Counsel who will
19	allocate the attorney fees based on agreements among counsel and those firms' work in the
20	litigation.
